- ✓ File name and post subject must correspond to the name and surname of the participant for example, Ivanov Petro Semenovitch) theses
 - ✓ Abstracts must be typed with text editor MS Word;
 - font in Times New Roman,
 - size for the text -14 pt,
 - interval –one and a half.
 - Text borders: top, lower, right – 15mm, left -20mm.
 - Abstracts volume is up to six full A4 pages.
- List of references must be executed in round hooks in text’s body
