Memorandum of Understanding

between

Eskişehir Technical University (ESTU), Eskişehir, Turkey

and

Petro Mohyla Black Sea National University, Mykolayiv, Ukraine

Eskisehir Technical University (ESTU), Turkey and Petro Mohyla Black Sea National University, Ukraine, agree to cooperate in international development of university community through mutually beneficial activities in teaching, joint projects, information, faculty and student exchange.

This agreement provides a collaboration for the exchange of academic staff, administrators, students, and academic information as well as materials between the signatory institutions. Establishment of such exchanges will enhance research and educational processes at the institutions and thereby expand the fields of knowledge and cultural awareness among the institutions and their respective faculties, administrators and students.

The institutions agree to promote the following activities based on their respective educational needs:

- 1. Organization of joint educational programs and projects.
- 2. Exchange of academic information and materials.
- 3. Exchange of faculty and administrators.
- 4. Exchange of students.
- 5. Organization of joint conferences, workshops, seminars (as well as online seminars) and exchange of information about conferences and workshops.

The implementation of each project based on this agreement shall be separately negotiated and determined by the institutions involved. Efforts shall be made by the respective institutions to find financial sources for carrying out the programs.

Nothing shall diminish the full autonomy of the individual institutions nor will any constraints be imposed by any of the institutions upon another in carrying out the agreement.

The Institutions bear mutual responsibility according to the terms of this Agreement. Each Institution shall maintain the other Institution's Proprietary Information with the least same degree of care each Institution uses to maintain its own proprietary information.

This Agreement enters into force from the date of its signing by the statutory representatives of both Institutions. The Agreement will be valid for 5 (five) years. Each Institution has the right to terminate this Agreement unilaterally, by providing a prior written notice to this effect to the

other Institution no later than 6 (six) months before the date of termination. The Agreement shall be extended automatically for an additional period of 5 (five) years at each expiration date unless either institution gives 6 (six) months advance notice in writing in order to terminate the Agreement. Any amendments and additions to the Agreement are to be made separately in the form of mutual agreements between the Institutions.

Both Institutions agree that the given Agreement is prepared only in English language in two copies, one for each Institution, both having the same legal force, and is signed by the first-level administrators of both Institutions.
