



MEMORANDUM of Understanding

**between the Faculty of Law of Petro Mohyla Black Sea National University (Ukraine)
and
Faculty of Law of State University of Moldova**

The Faculty of Law of Petro Mohyla Black Sea National University, Ukraine, represented by Dean Dmytro Sichko, and Faculty of Law of State University of Moldova represented by Dean Sergiu Băieșu have signed this Memorandum to develop mutually beneficial cooperation between the PARTIES.

1. Parties to cooperate in the international development of the university community through mutually beneficial activities in teaching, joint projects, information, faculty, and student exchange.
2. This agreement provides for the exchange of faculty, administrators, students, and academic information as well as materials between the Parties. The creation of such exchanges will advance research and educational activities at the institutions, broadening knowledge fields and cultural awareness among their faculties, administrators, and students. The Parties agree to promote the following activities based on their respective educational needs:
 - 2.1. Sharing information to support the educational process and scientific research activities;
 - 2.2. Joint arrangement of meetings, symposiums, seminars, workshops, conferences, cooperation days, and other events (including via the Internet) and exchange of information about conferences and workshops;

- 2.3. Development and delivery of joint seminars, conferences, training sessions, webinars, round tables, and other events on legal issues, including matters related to the implementation of European anti-corruption standards, as well as providing presentations at seminars and lectures for students on corruption prevention;
 - 2.4. Joint development of academic, scientific research, and other projects;
 - 2.5. Publishing of jointly written scientific or scientific and methodological works (articles and presentations) and joint projects in scientific collected articles of the Parties;
 - 2.6. Cooperation in development and implementation of joint study programs (bachelor's, master's, and doctoral study programs);
 - 2.7. Joint supervision of scientific research of doctoral students;
 - 2.8. Organization of training courses conducted by visiting professors from both Parties, subject to mutual agreement;
 - 2.9. Cooperation in the field of lifelong learning;
 - 2.10. Implementation of academic mobility programs for students and academic staff, including opportunities for students of both Parties to undertake modular (semester-long) studies within the academic programs of the respective structural units on a parity basis.
3. The implementation of each project under this Agreement shall be subject to separate negotiation and approval by the Parties. Each Party shall make efforts to identify and secure financial resources necessary for the execution of such programs.
 4. This Memorandum is concluded without imposing any mutual financial obligations on the Parties. All financial terms and conditions shall be specified in separate agreements subsequently concluded between the Parties
 5. *Nothing in this Memorandum shall diminish the full autonomy of either Party, nor shall any Party impose constraints on the other in the execution of this Memorandum.*
 6. Each partner will indemnify and hold harmless the other against all claims and actions brought against it.

6. Each partner will indemnify and hold harmless the other against all claims and actions brought against it.
7. This Memorandum shall remain in effect for five years from the date of signature and may be renewed or amended by mutual agreement of the Parties. Any amendments, as well as early termination of this Memorandum, shall require written notification submitted at least six months in advance.
8. This Memorandum is executed in two copies, each of equal legal force, with one copy retained by each Party.
